Therefore, the implementation of an internal institutional sustainability and eco-efficiency policy is considered necessary.

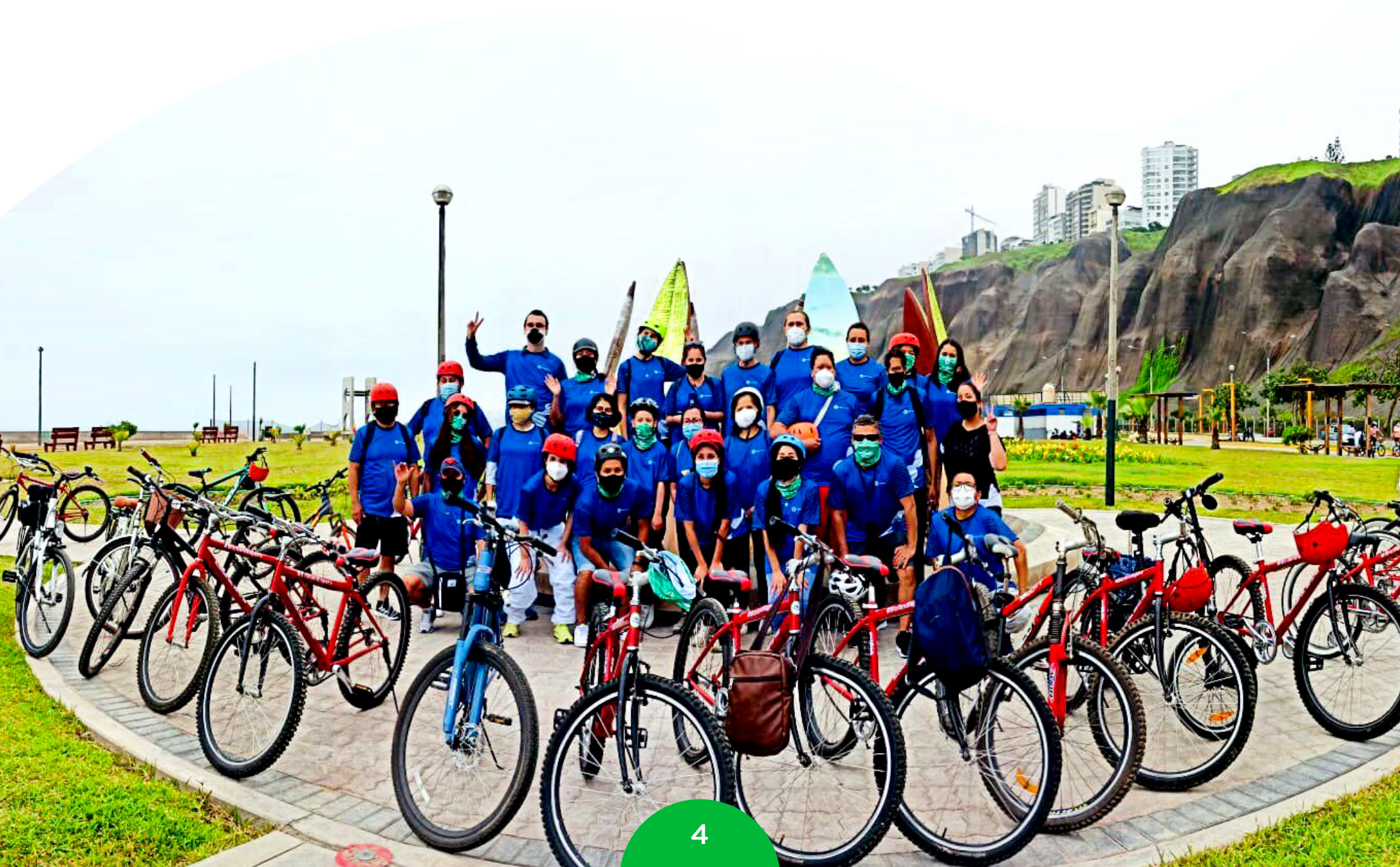


## 2 Strategic Objectives

## Relationship with other Profonanpe Policie

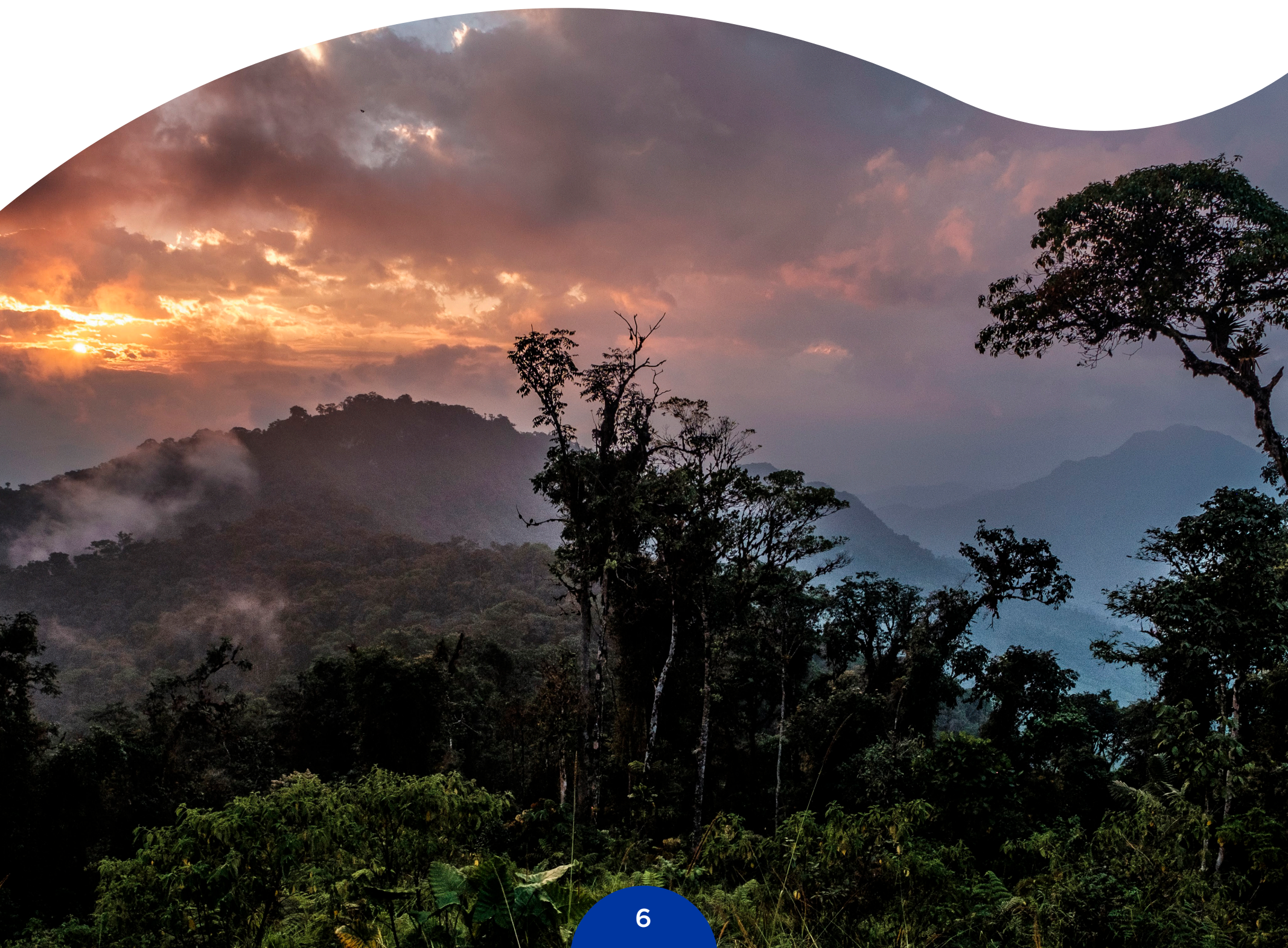
This policy is related to the Gender, Environmental and Social (ESP) Policy and the Code of Ethics, among other institutional policies.

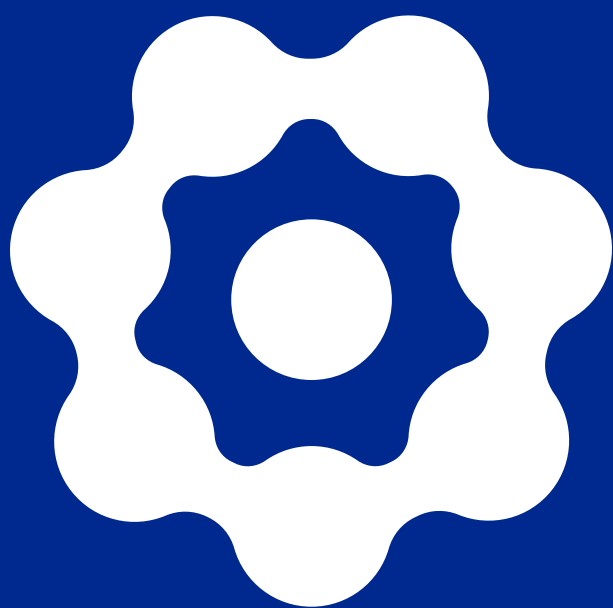
The implementation of this policy is developed in Profonanpe's GHG Reduction Plan.
